

Referral Promotion Terms and Conditions

1. The 'Referral' Promotion ("the Promotion") is offered by Tedworth Property Limited, registered company number 10877899 with its registered office at Suite 6, 121 Sloane Street, London, SW1X 9BW ("Tedworth Property," "we," or "us").
2. The Promotion is open to eligible participants who are 18 years or older, including employees of Tedworth Property but excluding any other persons connected with this Promotion.
3. The Promotion is available for a limited period only, commencing at 00:01 on 01/01/2026 and ending at 23:59 on 31/12/2026 ("the Promotional Period").
4. If you refer Tedworth Property to a third party within the Promotional Period, and the third party subsequently sells or lets a property through us ("Referral"), you will have the option to:
 - Request a £250 donation to a local charity of your choice ("Donation"), or
 - Receive a £250 gift voucher from John Lewis ("Voucher").

The Donation or Voucher will be issued only after Tedworth Property receives the full commission or fees from the Referral.
